Care cleaning: Remove the loose dirt from the surface. In case of heavy soiling, wipe with JORA-CARE-BASIC-CLEANER JZ7920-0-001 first. Add 1% of JZ7930-0-001 (50 ml to 5 l water) to the water and mix well. Wet the fibre cloth of a mop (e.g. surface wiper) with the cleaning water, wring it out and wipe the surface slightly damp. After a drying time of approx. 1 hour, an evenly matt, caring and protective film is formed. The wipe care should be used depending on the intensity of wear and tear. Do not work too wet to avoid swelling of the parquet.
