Use the WAX-POLISH undiluted and do not add to the mopping water!

Care: Vacuum the parquet floor and then wipe it lightly with a damp cloth (e.g. with JORA-CARE-BASIC-CLEANER) and let it dry. Apply thinly with a cloth or a single-disc machine and a white pad, rub in and allow to dry for approx. 20 minutes. Then polish the surface with a dry cloth or carpet residue or a white pad.

Professional cleaning: Massage in with the single-disc polishing machine and then polish with a white polishing pad. If necessary, rub/absorb excess material with a lint-free cotton cloth.

STORAGE

Storage:

Store material in a tightly closed container

Don't store below 5°C.

Shelf-Life:

12 months (when stored in the original unopened containers)
